# FOR AFC & FAM LICENSE 2018

All teams from Liga Super 2018 have officially applied for the FAM License, a condition that enables them to participate in the Liga Super 2019 competition.

The 12 teams included were Kedah, Perak, PKNP FC, Selangor, PKNS FC, Negeri Sembilan, Melaka United, Johor Darul Ta'zim FC, Terengganu FC, Kelantan, Kuala Lumpur and Pahang.

The teams with the exception of Pahang had also applied for the AFC License which enables them to compete in the AFC Champions League 2019.

Meanwhile, 10 out of the 12 teams in the Liga Premier 2018 had applied for the FAM License which makes them eligible to compete in the Liga Super 2019, if qualified by sporting merit.

The 10 teams are Pulau Pinang, Felda United FC, PDRM, Uitm FC, MIFA, Kuantan FA, Felcra FC, Sabah, Sarawak and UKM FC.

Two other teams, Johor Darul Ta'zim FC II and Terengganu FC II did not apply due to the their status as feeder clubs to Johor Darul Ta'zim FC and Terengganu FC from the Liga Super respectively.

#### FAM CLUB LICENSING EDUCATION WORKSHOP







The FAM Club Licensing Department conducted a 1 day workshop on matters relating to the Infrastructure criteria. It is part of a series of education workshops to be organized in 2018 to improve the understanding for the personnels at the club level who are in charge of the respective criteria as well as to expand the knowledge with new updates and informations happening around the world in today's football.

Guest speakers, instructors and experts from FAM, AFC and FIFA were invited to the workshop to educate and share knowledge to the clubs from the Malaysia Super and Premier league division.
